What Wheatley Peters Building Power Shutdown

When Thursday, August 7, 2025 (09:00 PM)

Friday, August 8, 2025 (05:00 AM)

Work Notice Description

As part of required electrical upgrades, a series of building power shutdowns are required to support installation of new equipment. This work will require that the building's electricity be shut off for a period of 8 hours. Emergency generators will be running while the normal power is off serving life safety (exit lights, elevators, ...) and those outlets previously dedicated to back up power.

This building power outage is scheduled for August 7th in Wheatley Peters Hall. Facilities staff have been working with our Environmental Health & Safety department and Venture Development Center to identify critical lab and other equipment that is either already on emergency power or making alternative arrangements during the power outage. A prior notification was issued by EH&S for this shutdown.

What to Expect

During the building shutdown:

- Normal power will not be on; occupants should plan to turn off their computers and other equipment when leaving on the day of the scheduled shutdown for their building.
- Emergency power will be provided and support those operational needs already on emergency circuits.
- Returning to work the following day will require that computers and other equipment be restarted by pressing the power button.
- Food items within refrigerators that cannot last 8 hours should be removed.
